

## **MEMBERSHIP RATES 2022**

HollandBIO is a privately-funded association. Any company<sup>1</sup> active in the broad field of biotechnology can become a member of HollandBIO. Companies that apply biotechnology or provide support services. To determine the membership rate, a distinction is made between biotechnology members and associate members.<sup>2</sup>

## **Biotechnology members**

Biotechnology members are companies that perform biotechnological activities. These activities entail the use of organisms such as plants, animals, fungi and bacteria -or parts of these organisms- for the development of new products or technologies in health, nutrition, agriculture, industry or the environment. The membership rate for these companies depend on sales revenues made by the Dutch BV/NV in 2020. Biotech companies with a sales revenue below €25 million are categorized by the number of employees at 1 January 2022. For companies established after 2017, with less than 7 employees and no sales revenue, the startup rate applies.

## Associate members

Associate members are companies<sup>1</sup> that are indirectly involved in biotechnology, because they offer services to biotech companies. Consultancy companies and law firms are examples of associated members. The membership rates of these organizations are based on the number of employees at 1 January 2022.

A HollandBIO membership year runs from January 1<sup>st</sup> to December 31<sup>st</sup>. However it is possible to become a member throughout the year. All memberships are automatically extended by another full membership year, unless a timely and written cancellation is received. A cancellation period of three months applies, i.e. no later than 1 October each year.
