Too much talk, too many rules and too little action... And if we don't act soon, we can wave our leading position goodbye.


Right now, we have a chance. With the EU Biotech Act, Europe is deciding on the future of biotech. We need to make bold moves, to make real impact.


The solution is simple and builds upon our strengths:

Political deadlock in a maze of bureaucracy




