

HOLLANDBIO MEMBERSHIP

Hollandbio is a privately funded association. Any company¹ involved in biotechnology can become a member of hollandbio: both companies that apply biotech and organizations that provide supporting services. To determine the membership fee, hollandbio distinguishes between three types of members²: biotech, biotech-as-a-service, and business.

MEMBERSHIP CATEGORIES

- **Biotech members** use biological systems and processes to develop new technologies or products. They conduct research, test the feasibility of their innovations, and work on scaling up towards market introduction. Their activities contribute to finding smart solutions for societal challenges, such as in the fields of health, nutrition, agriculture, industry, or the environment.
- **Biotech-as-a-service members** provide specialized, supportive products and services that directly contribute to biotech innovation. They work on behalf of biotech companies to develop, test, and commercialize biotech applications and possess in-depth knowledge of biotech processes, regulations, and market introduction.
- **Business members** provide specialized, supportive products and services that directly contribute to biotech innovation. They work on behalf of biotech companies to develop, test, and commercialize biotech applications and possess in-depth knowledge of biotech processes, regulations, and market introduction.

GENERAL MEMBERSHIP TERMS

- Hollandbio's membership year runs from January 1 through December 31.
- The membership automatically renews for a term of 1 year unless terminated in time.
- The notice period is three months, meaning terminations for the next year must be received by October 1 at the latest.
- Membership fees are adjusted annually based on the inflation rate³ published by CBS for the period August 1 to July 31, with a minimum of 0%.

Based on (a combination of) your organization's characteristics (in blue), these tables show your membership code (in green) and corresponding contribution amount (in white). Per category these are based on:

→ **Biotech (B)**: Number of employees in The Netherlands on October 1st, 2025, and revenue achieved worldwide in 2024.

→ **Biotech as a service (BAAS)**: Number of employees in The Netherlands and number of employees worldwide on October 1st, 2025.

→ **Business (ZD)**: Number of employees in The Netherlands on October 1st, 2025.

Example: A biotech member with 50 employees and € 25 million in global revenue falls under category B-5B with a contribution amount of € 14,501.
